GAMBLERS SERIES

IMPORTANT NOTE ON COMPETITION/POINTS:

THE OVERALL SEASON POINT RECORDING AND PROCESS WILL NOT IDENTIFY GROUP A OR B, AND WILL DETERMINE YOUR PLACEMENT BY TOTAL ACCUMULATED POINTS.

Delay boxes are not permitted to be used during any Gambler events. Any vehicle determined to be using a delay box will be eliminated from the competition immediately and forfeit any points earned in that event

The additional entry fee for Gamblers is \$20.00. There will be **no buy backs** permitted but we will be offering an option to purchase a mulligan at the time of entry for an additional \$20.00 which can be used in any round, with the exception of the semi-final or final round. The mulligan **MUST** be purchased at the time of entry and all monies collected WILL be awarded to the winning drivers as outlined in the payout section included in this handout.

IMPORTANT NOTICE: All gamblers and/or mulligan monies **MUST** be paid when you agree to enter the event and prior to the beginning of the first round and there is no option for entry once the competition has begun. There will be no prepay option and all monies must be paid in cash at the entry gate kiosk on the day of the event.

***No driver may change vehicles once eliminations have begun. However, a driver may enter a substitute vehicle before eliminations begin.

GAMBLER COMPETITION

1. Two ladders will be created within one gamblers event and we will split the field equally based on car/bike/sled count to be known as Group A and Group B.
2. For rounds one through four all quicker ET's go on one side of the ladder known as Group (A) with the slower ETs on the other known as Group (B).
3. When four (4) rounds of competition have been completed for groups A and B, both groups will be combined into one group. The combined A and B group will begin round five as one field and then compete until an overall winner has been declared. *In the event either group A or group B are reduced to four (4) cars or less at the completion of any round prior to the completion of round four (4) the groups will be combined at that time for the next round of competition.* Drivers in the combined group may carry forward their mulligan, if still valid, which may be used up to, but not in the semi-final or final round

4. ALL bikes and sleds, no matter what ET will be placed in Group (B) for rounds one through four. When groups A and B combine, bikes and sleds may be paired by card draw with any vehicle within the combined field.

5. If there are an uneven number of cars, the odd car will be placed in the most applicable field as determined by Eastbound Park race officials.

6. If the fields have been set, late entries will be placed in the field based on verifiable data. If we have no data available on a car for group identification it will be placed in the applicable ET field as determined by Eastbound Park race officials.

7. The Gamblers series will use card draw in the staging lanes for competition pairings, including bye runs and competition will be a full tree (sportsman tree).

Please note: If you have made a qualifying run on the event day, the ET recorded will be entered as your position in the field however track officials may adjust a placement if requested and warranted. No driver may change vehicles once eliminations have begun however a driver may enter a substitute vehicle before eliminations begin, provided that vehicle has passed technical inspection and been approved for competition on that day.

POINTS – GAMBLER

Answer the call for first round AND stage under your own power - 20 points

Round win - 10 points

Final round appearance AND stage under your own power (runner-up)- 1 point

Final round win - 10 points + 3 bonus points

.500 reaction time during competition - 1 point (gamblers only and multiples count)

GAMBLERS EVENTS PAYOUT

Final round winner (combined group only): 70% of pot

Final round runner-up (combined group only): 30% of pot
